About the DATA Scheme Working Group

- The Office of the National Data Commissioner (ONDC) established a Working Group to **identify the key issues** that impede uptake of the DATA Scheme under the DAT Act and identify potential solutions
- The findings will:
 - help the ONDC improve its operationalisation of the DATA Scheme
 - feed into the Commonwealth's considerations for the scheduled statutory review of the DAT Act
- The Working Group considered issues over a set of 8 focus topics

DATA Scheme focus topics

- Accreditation
- Exits and outputs
- Data sharing purposes and projects
- Data sharing agreements
- Scope
- Interaction with other legislation
- Definitions
- Dataplace

Key findings

- There was strong alignment on the issues raised among the Working Group
- There was a range of views on the restrictiveness as opposed to the flexibility of the DATA Scheme, including the Scheme's capacity to address certain issues under current settings
- Challenges inherent in implementing a new system include additional costs and cultural factors
 - ONDC needs to consider how to further reduce implementation and transaction costs in adopting the Scheme
 - ONDC needs to provide a clearer value proposition to guide when and how the Scheme should be used



ONDC considers the Scheme can accommodate many of the outcomes sought

ONDC acknowledges it has work to do to clarify and communicate its regulatory position about the way the Scheme operates

ONDC must do this in a way that reflects the flexibility Scheme participants are looking for

Issues summary

Overarching	The role and value proposition of the DATA Scheme is unclear		
Scope	There are restrictions on direct participation for certain entities		
	The value of accreditation is not consistently recognised		
Accreditation	The accreditation process is viewed as requiring considerable time and effort and the basis for assessment is not well understood, which leads to inefficiency and a lack of clarity		
State and territory data sharing	States and territories do not have equivalence with their Commonwealth counterparts in DATA Scheme projects, which can impede two-way data sharing and parity in joint data sharing projects		
Projects	The data sharing project boundary can be limiting		
Data sharing agreements	Data sharing agreements are long and complex		
Exits and outputs	Managing the exit of output from the Scheme is unclear and confusing		
Interaction with other legislation	There is a lack of clarity on how the DAT Act override interacts with other secrecy provisions and privacy legislation		
Dataplace	Approvals within Dataplace are inefficient and some data custodians are not using Dataplace fully		
Definitions	DAT Act terms and definitions do not align well with current data sharing 4

Next steps

- ONDC has started implementing the actions and aims to complete the high priority actions by early 2025
 - New products will be published on ONDC's website as they are completed
 - Advice on completion of systems/tools improvements will be provided to Scheme participants and through the DataPoints newsletter
- The Working Group agreed there would be value continuing as a consultative/reference group for the Scheme
 - ONDC will establish this under revised terms of reference and refreshed membership by early 2025



- 1. Implement high priority actions by early 2025
- 2. Form a consultative/ reference group for ONDC to enable Scheme participants to use the Scheme with confidence

Working Group members and consultation

- The Office of the National Data Commissioner established the Working Group in April 2024
- Members were invited from states and territories, as well as from Commonwealth agencies partnering on the National Disability Data Asset
- The Working Group met 9 times between April and September 2024
- Additional feedback was sought from the university sector and from state and territory agencies who were not standing members of the Group
